The Star-COLIBRI project (Strategic Research Targets for 2020 – Collaboration Initiative on Biorefineries) is a Coordination and Support Action funded by the European Commission's 7th Framework Programme for 2 years starting on November 1st 2009. The project involves 5 European Technology Platforms and 5 major European Research organisations. **IAR cluster was WP3 leader**.

The Bio-Based Industries Joint Undertaking is a new €3.7 billion Public-Private Partnership between the EU and the Bio-based Industries Consortium. Operating under Horizon 2020, it is driven by the Vision and Strategic Innovation and Research Agenda (SIRA) developed by the industry.

Many regional stakeholders joined the partnership including IAR Cluster.

IAR is one the 40 industrial founding partners of the Bio-based Industries Consortium (BIC). BIC is an association established in 2012 to represent collectively the partners of the private sector

  - Mapping of industrial biorefineries in Europe
  - Identification of hurdles and enablers of European biorefinery development.
