The Balearic Islands' agricultural authorities have reportedly uncovered a suspected food fraud involving the weight misrepresentation of 7 200 eggs imported from the mainland. An inspection revealed that the eggs were labelled as heavier than their actual weight, potentially deceiving consumers and violating trade standards. The authorities are conducting further investigations to determine the extent of the fraud and to hold responsible parties accountable. This incident highlights the ongoing challenges in ensuring food quality and authenticity in the market.

Four individuals in Mallorca have been sentenced for a significant fraud involving the sale of counterfeit olive oil. They admitted to selling low-quality and sunflower oils as extra virgin and organic, falsely labelling them as 'Oli de Mallorca' while sourcing them from mainland Spain. The Guardia Civil seized nearly 4 000 l of fraudulent oil. The defendants, including a family and a printer responsible for false labels, were convicted of industrial property crimes, forgery, and fraud. They received two-year prison sentences, fines, and were ordered to compensate affected businesses, although the prison terms were suspended.




