## Food Fraud Cases

In December 2025, Colombian authorities seized contraband and counterfeit goods worth EUR 1.7 million during "Plan Navidad" operations. The seizures included thousands of units of mislabelled or adulterated liquor and various food products lacking sanitary records.

Authorities in Bogotá dismantled a distribution center for counterfeit alcohol, seizing more than 4 000 bottles and boxes of various spirits (whiskey, rum, vodka, and champagne) valued at approximately EUR 92 500.

Police in Jamtara seized a massive consignment of spurious liquor worth approximately EUR 41 000 intended for Bihar. The operation resulted in the confiscation of 5 400 bottles, along with 78 gallons (3 120 l) of spirit concealed in bags of snacks inside a truck. Four alleged smugglers were arrested during the operation.

During a national inspection of 350 buffets and restaurants in Hungary, authorities confiscated 1 300 kg of non-compliant food products and imposed total fines of approximately EUR 44 700. The operation resulted in 85 legal procedures and the immediate closure of 25 units due to severe traceability and safety issues.

According to the authorities, a search of the premises revealed a total of 434 bottles of 1 l each and 568 bottles of 0.7 l, infringing the property rights of a well-known brand of alcoholic beverages.

In the warehouse, which had no business name and was hidden among residential properties, the officers found two alcohol storage tanks with a capacity of 10 000 millilitres each, a bottling machine, more than 7 000 bottles ready to be filled and another 2 000 in the process, as well as 20 000 caps, 1 000 stamps and 2 000 counterfeit security seals.

Turkish authorities conducted a massive nationwide operation against counterfeit alcohol, seizing 119 564 bottles of illicit liquids. The confiscated goods included 48 425 l of ethyl alcohol and 2 792 l of illegal beverages. This coordinated raid across 81 provinces led to the detention of 169 suspects and the dismantling of 12 illegal production sites.

Authorities in Sonbhadra confiscated 5 960 265 l of illicit Punjab-made liquor, comprising 15 669 bottles, after a truck overturned. The seized shipment, valued at approximately EUR 47 000, was concealed under sacks of rice to evade taxes during transit to Jharkhand.

Authorities in northern Morocco seized over 6 500 l of adulterated olive oil, targeting fraudulent practices in production areas. The seized oils were found to be non-authentic mixtures sold to unsuspecting consumers.

Police in Ahmedabad confiscated 7 108 bottles of illicit liquor hidden inside 1 144 boxes of Bournvita chocolate drink. The seized alcohol, including 750 ml and 180 ml whisky and rum bottles, was valued at approximately EUR 41 000. Authorities also seized a container truck, a car, and a motorcycle, bringing the total value of confiscated assets to nearly EUR 146 000.

The suspects are accused of repackaging decomposed food and distributing it illegally. Authorities discovered large quantities of unsafe food stored on a farm, along with related equipment and vehicles.

The 1 296 confiscated cartons were being smuggled into Ahmedabad for New Year celebrations. The total seizure, including the vehicle and assets, is valued at EUR 216 000, measured by a transport capacity of one heavy-duty truck.

Authorities in Antalya, Turkey uncovered a food fraud operation in which expired products were being relabelled with new expiration dates to make them appear safe for sale. The scheme was discovered during an inspection by the Ministry of Agriculture and Forestry. Officials found equipment used to print and replace labels, confirming deliberate consumer deception. All affected products were seized and destroyed to protect public health.

Police in Kwekwe intercepted a truck and confiscated 13.96 T of food products. The operation involved 698 bags (20 kg each) of fake Hulett's sugar. The seized goods, valued at approximately EUR 12 400, were being delivered to a local wholesale outlet without authorization. Four suspects were arrested for violating the Trade Marks Act following verification by the brand's loss control officers.

Moroccan customs authorities dismantled a large network of illegal warehouses used to store smuggled and counterfeit goods across several regions. The operation uncovered clandestine depots hidden as farms and stables, run by organized fraud networks using shell companies. Investigators identified major customs and tax fraud through falsified import documents and international data analysis. Seized goods included adulterated alcohol and spoiled spices.

Colombian authorities upheld sanctions against four dairy companies after detecting the illegal addition of lactoserum to milk. The investigation involved the analysis of thousands of liters of product, resulting in fines totaling approximately EUR 2.7 million.

The Portuguese Food and Economic Safety Authority seized 563 kg of frozen meat from a meat processing operator in Faro after inspections found serious irregularities in traceability, freezing and packaging practices that violated food-safety laws. The meat was judged abnormal and potentially unsafe, triggering both criminal and administrative actions against the operator.

The Turkish Ministry of Agriculture and Forestry added 36 new products to its official food blacklist of counterfeit or adulterated items that pose health risks, including olive oil, yogurt and honey. Recent tests found misleading labelling and contamination issues, such as starch in “plain” yogurt and mixed seed oils in supposed olive oil.

Authorities in Gurugram conducted a major raid at "The Theka Wine Shop," seizing approximately 40 000 bottles (3 900 cases) of illicit foreign liquor worth EUR 1.1 million. The products lacked valid holograms and were smuggled illegally into a licensed outlet to evade taxes. All units were confiscated during the evening operation after complaints revealed the sale of untracked goods. This seizure represents the largest ever recorded at a single high-end liquor vend in the state.

Italian authorities conducted a major raid in Rome's Esquilino district, seizing 1.5 t of irregular food products, including meat and fish. The operation resulted in fines of EUR 50 000, as the products lacked traceability and the appropriate health certifications. All non-compliant food items were confiscated and destroyed during the inspection to ensure public safety.

Customs officials in Tenkodogo seized a major shipment of smuggled liquor concealed within a large transport vehicle. The operation resulted in the confiscation of 363 cartons of smuggled alcoholic beverages, including vodka, whisky, scotch, sangria and other spirits, intended for illicit distribution during the year-end festive season. The products lacked the mandatory tax stamps and legal documentation required for the region.

The Navi Mumbai Excise Department seized 1 550 boxes of illicit Indian-made foreign liquor worth approximately EUR 170 000. Goa-manufactured alcohol was being smuggled into Maharashtra to evade taxes and bypass local bans. While no specific food quantities were confiscated other than the alcoholic beverages, the entire shipment was intercepted during a special drive for the Christmas and New Year season.

The Guardia di Finanza in Termoli seized approximately 1.5 t of illegally caught fish and 300 kg of fish lacking proper documentation. The operation involved several commercial activities where officers confiscated the fish to protect public health. The administrative fines imposed on the offenders totaled exceed EUR 200 000, as the products were deemed unsafe due to the lack of information regarding their origin and processing.

The Islamabad Food Authority dismantled a massive production unit in Khanna Syedan that was manufacturing 100 000 l of synthetic milk daily. The criminal operation involved mixing powder, water, and vegetable ghee to sell a hazardous liquid as pure milk. Authorities confiscated and destroyed 50 000 liters of prepared fake milk, along with 105 bags of powder and 250 tins of oil.

South Africa's agriculture minister confirmed that fake or adulterated honey has been found mainly in informal, non-franchise outlets, not major supermarkets, raising consumer and industry concerns; inspectors seized 1 059 honey-like syrups and 388 mislabelled products. These fake products are often diluted with cheaper sweeteners, misleading buyers and depressing prices for real beekeepers.

Authorities in northern Italy seized thousands of kilograms of beef linked to suspected food fraud after a TV inquiry showed expired frozen meat being thawed, relabelled and redistributed. About 1 500 kg destined for cruise ship catering were pulled from the market, 100 kg delivered to a restaurant were already consumed, and 3 000 kg sent to a pet food producer had also been used, prompting health officials to block and confiscate additional lots while investigations continue.

The Punjab Food Authority and IFA dismantled a major counterfeit and adulteration network near Faizabad. During the raid, officials confiscated and destroyed approximately 27 000 l of fake milk, along with 3 200 kg of ghee and 2 500 kg of dry milk powder. This illicit operation involved the illegal mixing of powder and vegetable oil to mimic real dairy.

In a joint intelligence-based operation, Pakistan Rangers Sindh and Customs enforcement seized a large consignment of smuggled goods hidden in warehouses near Yousuf Goth and Hub River Road. The confiscated food items included significant quantities of dry milk, Iranian toffees and chocolates, Chinese salt, dairy milk cream, and other assorted food items, transported in 10 trucks.

The primary fraud type was Adulteration, as laboratory tests revealed a mixture of olive and seed oils sold as "100% Italian extra virgin olive oil," along with Misbranding due to labels lacking mandatory traceability information.

But the wine collection disappeared in an unprecedented manner, after it was blocked by Bureau of Investigation officers and the Customs Investigation Directorate. Currently, no physical quantities remain confiscated as the product "disappeared without a trace" from the owner's villa.
