| <p>Overall policy is set by the Global Approach to Migration and Mobility (GAMM) framework. As part of the Development Cooperation Instrument (DCI), notably the Global Public Goods and Challenges (GPGC) thematic programme, DG DEVCO supports strategies and legislation in all aspects of migration governance, while promoting mobility and well-managed legal migratory flows. It aims at enhancing the positive impact of increased regional and global migration and mobility of people, on economic, social and environmental development, while improving the understanding of the migration–development nexus.</p> <p>Besides engaging in policy dialogue with developing countries at national and regional level on migration, DG DEVCO is also implementing concrete projects in this area. Beyond national and regional programmes, it manages the <i>“Emergency Trust Fund for stability and addressing root causes of irregular migration and displaced persons in Africa”</i>, made up of €1.8 billion from the EU budget and European Development Fund, combined with contributions from EU Member States and other donors. The Trust Fund covers a wide range of countries across Africa encompassing the major African migration routes to Europe. These countries are among the most fragile and those most affected by migration.</p> <p>In April 2016 the European Commission outlined a new approach to forced displacement and protracted refugee situations, based on integrated services and greater livelihood opportunities and a holistic approach including humanitarian, development and political action.</p> <p>In June 2016 the European Commission set out plans for a new results-oriented Partnership Framework to mobilise and focus EU action and resources in our external work on managing migration.</p> | <p>GAMM, international dialogue, Partnership Framework, forced displacement</p> |
